Art. 4.6 Entry fee refunds

The Organizer will reimburse the entry fees, minus a variable retainer, to competitors who were unable to participate in the event for the reason of force majeure, subject to the written application to the Organizer. The deduction will be:

- 25% of the entry fee for the requests received until 60 days before the administrative checks on Dec 1st, 2022.
- 50% of the entry fee for the requests received less than 60, but until 30 days before the administrative checks on Dec 1st, 2022.
- 100% of the entry fee for the requests received less than 30 days before the administrative checks on Dec 1st, 2022.

All the amounts will be refunded a maximum one month after the event.

Art. 5 Insurance Cover

Art. 5.1 Public liability cover

The entry fee includes cover for civil liability of the Competitor from 1st December 2022 to (and including) 3rd December, 2022. Competitor vehicles are covered for civil liability towards third parties (Road Legal).

The insurance company: Dubai National Insurance & Reinsurance P.S.C.

Contract no.: 09/571/58C/2022/19

This cover provides for a maximum liability, in respect of any one claim or series of claims resulting from one accident, of USD 1,500,000.00.

Damages to rally and/or service cars as well as the liability of a crew member towards other crew members are not covered by the insurance provided by the Organizers. This includes as well any damage during the race to the competition vehicles itself.

Art. 5.2 Overseas & GCC entries Cover

An accident & Sickness Emergency Medical and Repatriation expense is included in the entry fee to a level of AED 90,000 in excess of AED 15,000.

Art. 5.3 Declaration in case of accident

In case of an accident leading to an insurance event, the competitor or his representative must make a written statement to the Clerk of the Course, the Competitors Relations Officer, or directly to the Organizer, within 24 hours. This statement must mention the accident circumstances, the names and addresses of the casualties, as well as contact. Any breach of this rule will be reported and may result in a penalty, at the discretion of the Stewards.

Nevertheless, if a driver taking part in the rally is involved in an accident in which a member of the public sustains physical injury, the driver concerned must report this to the next radio point as specified in the road book and point the place on the route. If he fails in observing this rule, the Stewards may impose a penalty to the responsible crew, which may go as far as disqualification.

Art. 5.4 Individual accident insurance

It is highly recommended to take out additional individual accident insurance, which may allow the Competitors to cover additional costs, with an insurance company of their choice.

Art. 5.5 Medical insurance rules in UAE

It is important for all Competitors to fully understand the situation with regards to medical expenses according to the UAE rules.

In the event that "you" the registered competitor have an accident during the event and require medical attention in a hospital then the following procedure needs to be followed:

 On release from Hospital any Medical costs needs to be settled by you or third party before leaving the hospital. The hospitals have been informed of this arrangement.

In case of accident, a claim form will be sent to you or third party by email, which needs to be completed along with the Hospital report and receipt.

Once received and verified, then these documents are forwarded onto our Insurance Company for review and process.

By the fact to sign your entry form, you fully understand the above, and that Medical costs must be settled before leaving the hospital.

Art. 5.6 Road insurance for Overseas Service Vehicles

Competitors are reminded that Service Vehicles that are registered overseas, **entering by boat**, **by air or by road are not insured in the UAE**. The Organizer is able to Insure such vehicles for the duration of the event, provided that said vehicle/are registered with the Organization utilizing the official event SERVICE VEHICLE REGISTRATION FORM and notably, also submitting a clearly scanned colour copy of the vehicle registration certificate (all pages/both sides). All documents will be verified at Administrative Checks.

Competitors are furthermore reminded that UAE Rental Vehicles and all insurance related obligations are the sole responsibility of the competitor.

Art. 6 Advertising and Identification

See Appendix 3 of these SR "Decals and positioning of supplementary advertising".

Restrictions on advertising

The competitors are allowed to affix any kind of advertising to their vehicles, provided that:

- It is authorized by the FIA regulations and the legislation of the UAE.
- It is not likely to give offence.
- It is not political or religious in nature.
- It does not encroach upon the spaces defined below reserved for plates, race numbers and windscreen strips.
- It does not interfere with the crew's vision through the windows.
- It does not contravene UAE Law that strictly prohibits the advertising of alcohol products or gambling services.

For competitors who refuse the Organizer's advertisement, the amount of the entry fees will be increased by 60% (without reduced entry fees).

The crews must ensure that the advertising is properly affixed throughout the running of the Event. If compulsory or optional advertising is absent or wrongly fixed, a penalty of 10% of the entry fee will be incurred for a first offence, and 100% of the entry fee for a repeated offence. In case of damage, spare stickers need to be requested to CRO.

Art. 10.1.1 Timetable for scrutineering

A schedule for each competitor will be published in a bulletin.

Any crew reporting to scrutineering outside the time limits prescribed in the regulations will not be allowed to start, except in a case of force majeure duly recognized as such by the Stewards.

Any vehicle and/or crew arriving **more than 15 minutes** later than the scheduled time will incur a penalty of €50 for every 15 minutes of lateness.

Only those crews who have completed the administrative checks may present their vehicle at Scrutineering in accordance with the published time schedule.

Art. 10.2 Mandatory documents

- Complete original FIA Homologation Document (T2)
- FIA Technical Passport (or ASO Technical Passport)
- SOS / OK board (DIN A3 format)

The installation of the tracking system and the NAV-GPS will be checked at scrutineering.

The complete original FIA homologation form, the FIA Passport and other necessary certifications must be available for final checks.

Sealing holes must be drilled in advance with sealing wires in place. Old sealing tags must be removed and will not be accepted.

IMPORTANT REMINDER: The act of presenting a vehicle for scrutineering is considered an implicit statement of conformity.

Competitors must comply with the following when arriving for scrutineering:

- All rally plates; competition numbers and advertising plates must be in position
- For all vehicles the cylinder block and restrictor will be sealed. Sealing holes must be drilled in advance with sealing wires in place. Old sealing tags must be removed and will not be accepted.
- For T2 the presentation of the vehicles complete original FIA Homologation form in Scrutineering is compulsory.
- Produce safety helmets, Frontal Head Restraint (FHR) and safety clothing for inspection for compliance to FIA Safety Regulations (FIA Appendix L Chapter 3).
- Produce FIA Technical Passport & completed FIA Scrutineering Form (distributed at administrative checks).
- Produce and deliver the Scrutineering booklet as issued at Documentation.
- Produce GPS / Sentinel in working order, fitted permanently to the vehicle.
- Produce the provided tracking device in working order.
- Produce First Aid and Safety / Survival equipment. See Appendix 6.

Scrutineering carried out before the Start of the rally will be of a general nature to ensure general conformity with the Group and Class entered, essential safety items are carried and conformity with the national Highway Code, this Scrutineering does not in any way infer that the vehicle in concern complies with the technical regulations.

Art. 10.3 Mud flaps

According to Art. 25.3.4 of the FIA CCRSR mud flaps, in compliance with the Appendix J Art. 283-19, must always be in place and efficient.

Art. 10.4 Drivers' safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices, must be presented for scrutineering. They shall be checked for compliance with Appendix L, Chapter III.

The cars must be equipped with the medical kit according FIA CCRSR Appendix III-1 and FIA Technical List n°83 and the survival kit according to FIA CCRSR Appendix III-2.1. Because the

selective sections are run in the desert/dunes the survival kit according to FIA CCRSR Appendix III-2.2 must be carried on board of the car.

Art. 10.5 Installation of the Safety Tracking System and Navigation System

Art. 10.5.1 Safety Tracking System (FIA CCRSR Art. 12.1)

All vehicles must **only** be fitted with the Safety Tracking System(s) provided by the Organiser. The instruction for the use of the Tracking System is in the Appendix 5 of these Supplementary Regulations.

A dual GSM/Satellite Tracking System supplied by Sportraxx will be used. The cost of the service has been included in the Entry Fee and no additional brackets, wiring or aerials need to be purchased or fitted.

Art. 10.5.2 Navigation System (NAV-GPS; FIA CCRSR Art. 12.2)

Competitors are obliged to be equipped with one or two Navigation System(s) (NAV-GPS) downloaded with the waypoints given by the Organiser. When a crew uses two NAV-GPS, it must indicate in writing, at scrutineering, which of the two will be considered as the official one.

GPS UNIK IV with integrated Sentinel

The mandatory equipment is not included in the cost of the Entry Fee or ordered on the competitors' behalf by the Organizers.

Art. 10.5.3 Connection of the Systems

The specifications for the standard power connector are laid down in the FIA CCRSR Appendix VI.

It is the competitor's responsibility to ensure that the Safety Tracking System(s) and the NAV-GPS always remain permanently connected and switched on with the antenna connected throughout the duration of the competition.

Art. 10.5.4 FIA GPS Data Logger

Vehicles selected by the FIA after the publication of the entry list may be equipped with an FIA GPS Data Logger to monitor their performances during the event.

See FIA CCRSR Article 13.1.

Art. 10.5.5 FIA Accident Data Recorder (ADR)

An Accident Data Recorder (ADR) complying with FIA Standard 8872-2018 "Accident Data Recorder" (listed in Technical List no. 88) must be installed in T1 cars manufactured from 2016 that participate in any Championship event. The ADR must be installed in accordance with the FIA ADR Installation Specification and manufacturer user's manual.

Art. 10.5.6 FIA On-Board Surveillance Camera (FIA OBSC)

Vehicles selected by the FIA may be equipped with an FIA OBSC to monitor all activities inside the vehicle during the event.

Art. 10.6 On-Board Cameras

See FIA CCRSR Article 11.

If required by the Organizer, a competitor must carry an on-board camera or other recording

device and both the fixation and the location must be approved by the scrutineers according to the requirements of the Art. 283-2.

On-board cameras can be fitted, if duly requested and installed according to Art. 283-2 and Art. 11 of the 2022 FIA CCRSR. Competitors wishing to use a camera inside their vehicle must inform the Organization in writing or email:

bryan@emso.ae before 30th November 2022.

Art. 10.7 Electronic Equipment

Any radio or electronic means of communication, or any other device not expressly permitted in FIA CCRSR regulations is forbidden on board the vehicles.

Only in case of problems may telephones be used, only outside of the vehicle, with the vehicle stopped, to signal a retirement, an accident or a breakdown. These telephones may be used from within the car, only on road sections and solely by the co-driver. All infractions will result in penalties up to and including disqualification from the event.

Art. 11 Other procedures and regulations

Art. 11.1 Drivers' Briefing

See programme (SR Art. 3)

At the first briefing of the event, the participation of at least one crew member is compulsory.

Art. 11.2 Pre-Start Area

Before the start of the competition element of the event, all the competing vehicles will be assembled in a starting area, into which vehicles must be driven before the start time as detailed in a Bulletin.

Art. 11.3 Ceremonial start procedures and order



Art. 11.4 Electronic start procedure at the start of a Selective Section

Sporttraxx starting equipment is based on a LED starting light, which shows the full FIA countdown through LEDs that are working as per the picture below.

The car gets aligned on the starting line. Depending on the starting interval (1-2-3 minutes) the marshal will stand in front of the light to the crews point of view. Once he enters in the right starting minute, he will advise the crew that they have to follow the LED instructions, then the marshal will move from in front of the car.

LED light will display 30-15-10-5-4-3-2-1 and finally green which stays on for 20 seconds (the time the car is allowed to delay a start).



Art. 11.5 Qualifying Stage

There will be no Qualifying Stage.

Art. 11.6 Ceremonial Podium Finish / Prize-Giving

The prize giving ceremony will start on Saturday 3rd December 2022 at 19:00 on the Dubai Festival City Waterfront

Art 11.6.1 Parc Fermé

On Saturday 3rd December, all the vehicles will enter in "Parc Fermé" next to the Service Park after completing Leg 2.

Before entering in "Parc Fermé" all navigation and safety devices will be removed by the service provider.

The onus is on the Competitor to immediately collect the holding deposit from EMSO Account Department in Documentation room.

In case of deposit refund by bank transfer requested by the Competitor or Team, a mandatory electronic transfer fees would be systematically applied.

Art. 11.7 Permitted early check-in

At TC 1A Parc Fermé In, TC 2A Service In

Art. 11.8 Official time used during the event

Gulf Standard Time Zone (GMT +4)

Art. 11.9 Road books delivery

- An electronic Road book will be used for 2022 Dubai International Baja.
- The modifications of the opening team will be in the road book.

Remember: The only official route is the one in the Road Book.

The GPS Code/Electronic Road Book will be activated automatically as the vehicle approaches TC0/TC1/TC2.

Art. 11.9.1 Official Itinerary

The official route of the Baja is described in the road book given to the competitors and must be strictly followed, on pain of a penalty which may lead as far as disqualification from the rally.

The official itinerary of the Baja is defined by a number of Visible Way Points (WPV) and Eclipsed Way Points (WPE). All the GPS points will be considered as COMPULSORY passage points.

In any case the competitor can force the GPS to address to another WPT, pushing the "WPT+" or "WPT-" button.

The road book has been composed to indicate the route to follow, some GPS points and the main dangers.

Art. 11.9.3 Navigation rules

Throughout the Baja, each Competitor is responsible for the correct functioning of his GPS, downloaded with the Organization's points. The GPS must be connected to the power source at all times (Liaison & Special).

Each malfunction must be communicated to Clerk of Course or the CRO. Any evidence of manipulation may be penalized as far as disqualification from the Baja as determined by the Stewards of the meeting.

Art. 11.9.4 Penalties

For every Stage, the penalties for WP missing will be:

- WPV, WPM, WPE, WPC, DZ, FZ: 15 minutes
- WPS: 15 minutes.

Art. 11.9.5 Traffic regulations

Throughout the duration of the Rally the Competitors must strictly comply with the traffic regulations of the UAE. Any competitor who does not comply with these requirements will be penalized.

If the Police stop any Competitor, the Competitor needs to inform immediately Rally control and keep calm. An Arabic letter will be given at Documentation to show to the Police in case they stop you.

Art. 11.9.6 Crossing of inhabited areas

Along inhabited areas crossed in the liaison sections as well as along the Specials, the speed will be strictly limited as specified by the local sign panels. All areas that are considered dangerous for riders and for local inhabitants will be indicated in the road book.

Art. 11.9.7 Helping at an accident

It must be remembered that ethics demands that a Competitor who sees that an accident has occurred must stop in order to provide assistance in the most appropriate manner until the rescue service arrives. Also, it must be remembered that major means are implemented to shorten the intervention times.

Any Competitor that witnesses an accident placing another competitor in physical danger must:

- Stop,
- Press the SOS button on their tracking System,
- Establish contact with rally HQ to report the situation,
- Wait for the rescue service or another competitor to arrive, and then,

Inform Rally HQ when that they are leaving the scene.

At the request of the competitor on arrival at the end of the Leg before 17h00, the stopping time during the incident will be deducted from the time taken to cover the Selective Section.

Any competitor not complying with the above regulations will be reported to the Stewards who may impose penalties up to and including exclusion from the event.

Art. 11.10 Service

Art. 11.10.1 Service Areas / Bivouacs

The Service Park will be in the vicinity of Dubai Festival City Mall.

The speed of vehicles in the service park may not exceed 30 km/h.

From TC0 onwards, service of a competing car may be carried out in Service Areas (Service Parks and Bivouacs) and road sections as permitted under the FIA CCRSR.

Access times for service crews and service vehicles will be according to the Program of the event.

Only the Competitors and racing vehicles, Service Crews and Service Vehicles are allowed to enter in the Service.

The ID bracelet supplied by the organisers must be correctly attached to the wrist of competitors, crew and service personnel. This is considered the only authorization to be present in an official location, service area and the Service Park. Personnel must show the ID bracelet at any time on request.

Spectators will be allowed into the service park during certain times and will have a unique coloured wristband to designated them from other competitors or crew.

The movement of service/assistance vehicles is strictly controlled and is forbidden along the route of any Selective Section.

A layout of the Service Park will be sent to the Competitors one week before the event.

Art. 11.10.2 Flexi Service

To facilitate Teams with more than one car entered on the event a Flexi-Service system will be operated at the end of Day one.

Competitors should check in to Parc Fermé on arrival at TC1A where early arrival is permitted (Dubai Festival City Mall – Service Park). The competitors may then either:

 Go directly to service where two hours are allowed before checking back in to Parc Fermé

or

- May check into Service at a time of their choice until 20h00 at the latest.
- After TC1A In (Dubai Festival City Mall Parc Fermé) all checking in and out may be carried out by a team member without the presence of the crew.
- There is no penalty for early check in to Parc Fermé after service.

Only three registered Service Crew members may work on a competing vehicle at any time. They will be identified by a distinctive armband. The organizers will issue these three armbands to each Team.

Art. 11.10.3 Service allowed

- Service in the Selective Sections (Stages) is not allowed.
- Service outside the service park is not allowed.

Art. 11.10.4 Fuel and Refueling Zone

The refueling zone will be provided by the Organiser at:

- Dubai Festival City Mall, inside Service Park
- On stage according to the road book for T3/T4 only.

Reminder: for T3/T4 the team must have the FIA Approved refuel couplers installed and must carry a refueling funnel at all times.

Art. 11.11 Special procedures and activities

Art. 11.11.1 Shakedown

Shakedown is only allowed on December 1st according to the timetable. Use of the shakedown area is not permitted after 16h00.

No competitor will be allowed to start the Shakedown until their vehicle has passed scrutineering

Specific details and procedures for utilisation of the shakedown stage will be publicized during the week prior to the event.

A map with the location will be available at Rally HQ. Teams need to remain wary that the location could be in use by more than one team simultaneously.

Art. 11.11.2 Availability of participants

Participants who park their vehicles in the Parc Fermé upon passing the finish line, must remain available by phone (mobile) until the final classification has been posted.

Art. 11.11.3 Classification

The final classification will not be distributed after the event. The final classification will be published on website www.dubaiinternationalbaja.com and on the Digital Notice Board.

Art. 11.11.4 Speed Control Zones

All Liaison Sections are subject to prevailing traffic speed limit posted.

On both Selective Sections, at approximately 65 Kms and 130 Kms, there is a 40 kph Speed Control Zone (at the location where the Moto, FIA T3/T4 and National Class categories divert off route to refuel, and then rejoin to restart). The above zones are clearly indicated in the Roadbook and are electronically controlled by NAV-GPS

Art. 11.11.5 Starting Order

- The starting order of Leg 1 will be by ascending Competition No.
- The starting order of the second Stage will be made in the order of the Selective Section overall classification, or the accumulation of the Selective Sections of the previous day.

Art. 11.11.6 Minimum interval between the last Bike/Quad & the 1st FIA car

The last Bike/Quad will be scheduled to start a minimum of <u>60 minutes before the first FIA car</u>. Should the last Bike/Quad report late, but within his maximum lateness, the first car will still start on schedule.

Art. 11.11.7 Minimum interval between the last FIA Car & 1st FIM SSV

The Competitors in category 3 FIM SSV will start 10 minutes after the last FIA car.

Art. 11.11.8 Mechanical problem

In the event of a mechanical failure / retirement during a Leg, in this case, you must notify the Clerk of the Course that you consider yourself to be retired on that Leg and request his permission to recover the vehicle and/or receive outside assistance (Authorized Assistance). You can wait for the Sweep/Course Closing Team to arrive and they will take you back to the time control at the end of the leg. You must make your own personal arrangements, at your cost, for the recovery of your vehicle.

Art 11.11.9 Cover Images – Image rights

The Drivers/Riders & their Team recognize that the 2022 Dubai International Baja is a promotional operation from which they can benefit by the coverage they acquire there.

The Organiser holds all the rights necessary for the production and retransmission, by all means and, in all mediums, all over the world, images and sounds related to this event. In order to allow the widest possible dissemination and promotion of the 2022 Dubai International Baja, any person participating in the Rally is subject to the rules and acknowledges that his participation in the event authorizes the organizer and his rights holders, or others having cause to reproduce and represent, without remuneration of any kind, his names, voice, image, biography and more generally his sports performance in the framework of the Baja 2022 as well as the brand/s of its suppliers, manufacturers and sponsors, in any form, on any existing or future medium, in any format, for any communication to the public worldwide, for any use including for advertising and / or commercial purposes without any other limitation than those referred to below, and for the duration of the protection currently granted to these holdings by the laws or regulations, the judicial and/or arbitral awards from any country as well as current or future international conventions, including any extensions that may be made to this duration.

Mediation



Appendix 4 - Extracts from FIA ISC Appendix L relating to overalls, helmets and any other safety requirements

All competitors are reminded of Appendix L of the FIA International Sporting Code, in particular its Chapter III - Drivers' Equipment.

Helmets (Appendix L, Chapter III, Art. 1)

All crews must wear crash helmets homologated to one of the following FIA standards:

8858-2002 or 8858-2010 (Technical List N°41), 8859-2015 (Technical List N°49), 8860-2010 (Technical List N°33), or 8860-2018 or 8860-2018-ABP (Technical List N°69)

Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3) See Page 51/78 App L.

All crews must use FIA approved FHR systems homologated to FIA standard 8858.

Approved FHRs, anchorages and tethers are listed in Technical List N° 29.

See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

Flame-resistant clothing (Appendix L, Chapter III, Art. 2)

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard (Technical List N°27) or 8856-2018 (Technical List N° 74). Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) as well as concerning the correct wearing of the clothing elements! See also FIA Cross-Country Rally Sporting Regulations Article 48.1.

For all FIA priority drivers and co-drivers, the use of 8856-2018 clothing equipment is mandatory.

Biometric Devices (Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.

If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.

If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

Wearing of jewellery (Appendix L, Chapter III, Art. 5)

The wearing of jewellery in the form of body piercing or metal neck chains is prohibited during the competition and may therefore be checked before the start.

MEDICAL AND SURVIVAL KIT (Appendix III of the Cross-County Rally Sporting Regulations)

A sealed and valid Medical kit in accordance with the Specification for Cross Country Rallies and Bajas (Technical List n°83) must be placed inside the cockpit. The minimum weight must comply with Technical List n°83.

Default settings are adapted to Rally-Raid navigation. Do not touch it unless you are sure what you are changing.



Sentinel function

Overtaking

You want to overtake: press for a long time (more than 2s) on the yellow button or on the STN button of the remote control to send a signal to the vehicle ahead (less than 200m).

Somebody wants to overtake you: you hear Beep beep beeep – Beep beep beeep Get ready to let the vehicle pass a.s.a.p.



To inform the vehicle which wants to overtake that you have heard is signal and that you are going to let him pass a.s.a.p.

Press briefly the yellow button or the STN button of the remote control

(less than 2s - which cuts the sound in the cockpit)

If you don't acknowledge receipt of the signal, an acknowledgement of receipt is automatically sent at the end of 6s.

Accident

If you breakdown or if you have a crash <u>in a dangerous place (after a turn or a dune)</u>: press the <u>red Alarm button</u>, you will send a signal to the competitors maximum 250m around regarding the ground.

To stop it, press again the red Alarm button



There is an accident near by: you hear **Beeeep – beeeep – beeeep**

Note:

The Overtaking function is inactive when the vehicle is stopped or at the bivouac.

The Alarm function is automatically deactivated as soon as the vehicle runs above 20km/h.
